The Government has issued orders vide reference cited, to collect the following fee for the UG programmes:

One time payment per student at the time of admission towards Admission /Registration / Recognition fees	Rs. 2000.00
Rs.1,000/- per annum per student during the 4 year Course towards students related special services rendered by them	Rs. 1000.00
common services fee rendered by the University to all the colleges as mentioned in the GO per annum per student	Rs.1500.00
Library deposit and Laboratory deposit by way of refundable caution deposits at the time of admission only as one time payment	Rs.1000.00
An extra amount is allowed to be collected from each student towards tuition fee over and above the tuition fee fixed, for such of the courses which are given Accreditation by the National Board of Accreditation in any college as long as such accreditation is continued.	Rs.3000.00

The Principals of the Constituent Colleges/Affiliated Colleges are requested to collect the above fee only from the students and follow the Government Orders scrupulously. Further, the candidate who are eligible for reimbursement of tuition fee and special fee from the Government, you have to collect an amount Rs.1000/- only and remaining amount of Rs.4,500/- will be reimbursed by the Government in due course.

Once again you are requested to collect the above fee only from the students who are taking admissions for the academic year 2011-12 in your College and not to collect any additional fees from the students, deviating the Government orders.

The following notification shall be published in the Andhra Pradesh extra-ordinary Gazette on 05-08-2011.

**Notification:**

In exercise of the powers conferred under rule 8 and 9 of the Andhra Pradesh Un-aided Minority / Non-Minority Professional Institutions (Regulation of Admissions into Under-Graduate and Pharm-D (Doctor of Pharmacy) Professional Courses through Common Entrance Test) Rules, 2011 issued in the G.Os 2<sup>nd</sup> to 4<sup>th</sup> read above, read with sub rule (v) of Rule 4 of the Andhra Pradesh Admission and Fee Regulatory Committee (For Professional courses offered in Private Un-aided Professional Institutions) Rules, 2006 issued in the G.O 5<sup>th</sup> read above and in pursuance of the resolution of the Committee(AFRC) in their meeting held on dt.28.06.2011, the Governor of Andhra Pradesh hereby notify the following fee and special fee structure for Under-Graduate Engineering courses including Pharmacy, Planning and Architecture and Pharm D courses in Private Un-aided Institutes in the State of A.P. for the academic year, 2011-12:-

**1) For Under-Graduate Engineering courses including Pharmacy, Planning and Architecture Courses:**

The Tuition fee is fixed:

- At Rs.31,000/- (Rupees Thirty one thousands only) per annum for each student for A- Category Seats:
- Upto Rs.95,000/- (Rupees ninety five thousands only) per annum for each student, other than the NRI students in B-Category seats; and

- Upto 5000 U.S Dollars/- (Five thousands U.S.Dollars only) per annum for each NRI/NRI Sponsored student admitted in B-Category seats as per the provisions of G.O.Ms.No.74 & 75, HE (EC) Dept., dt.28.07.2011 in the Private Unaided Under-Graduate Engineering including Pharmacy, Planning and Architecture Colleges for the academic year 2011-12.

2) **For Pharm. D Course:**

**The tuition fee is fixed:**

- At Rs.68,000/- (Rupees sixty eight thousands only) per annum for each students for A-Category Seats.
- Upto Rs.1,55,000/- (Rupees one lakh fifty five thousands only) per annum for each student other than the NRI students in B-Category seats: and
- Upto 6000 U.S. Dollars/- (Six thousands U.S.Dollars only) per annum for each NRI/NRI Sponsored student admitted in B-Category seats as per the provisions of G.O.Ms.No.74 & 75, HE (EC.2) Dept., dt.28.07.2011 in the private un-aided Under-Graduate Pharm.D Colleges for the academic year 2011-12.

3) An extra amount of Rs.3000/- (Rupees three thousands only) per annum is allowed to be collected from each student towards tuition fee for 'A' & 'B' category seats, over and above the tuition fee fixed for such 'A' & 'B' category seats mentioned in Clause (1) above, for such of the courses which are given **Accreditation** by the National Board of Accreditation in any college as long as such accreditation subsists for such courses in that college relating to Under-graduate Engineering including Pharmacy and Architecture and Pharm.D courses.

4) The Committee has also resolved to fix the amounts under various heads towards Special Fee for Under-graduate Engineering Courses including Pharmacy, Planning and Architecture and Pharm.D Courses for the academic years 2011-12 and 2012-13 as specified below

- The Private Un-aided Engineering Including Pharmacy, Planning and Architecture Colleges and Pharm.D Colleges are permitted to collect:
  - i) Rs.2,000/- as one time payment per student at the time of admission towards Admission / Registration / Recognition fees and out of the said amount of Rs.2000/-, an amount of Rs.500/- shall be remitted by the Institutions to the concerned University and the remaining amount of Rs.1,500/- shall be retained by the Institution.

- ii) Rs.1,000/- per annum per student during the 4 year Course towards students related special services rendered by them as detailed below and the said amount shall be retained by the Institutions:-

- iii) Rs.1,500/- per annum per student during the course towards the common services rendered by the University to all the colleges as mentioned below and such amount collected by the Colleges shall be remitted to the concerned University:-

- iv) Rs.500/- towards Library deposit and an amount of Rs.500/- towards Laboratory deposit (total Rs.1000/-) by way of refundable caution deposits at the time of admission only as one time payment.

5) The following directions are also given to the concerned Private Under-Graduate Engineering including Pharmacy, Planning and Architecture and Pharm.D Colleges:-

- i) The students admitted to the course during this academic year 2011-12 shall pay every year the same annual tuition fee as paid at the time of their admission till they complete the course.
- ii) The students who were admitted in the courses prior to the academic year 2011-12 shall continue to pay every

year the same annual fee at the rate existing at the time of their admission till they complete the courses.

- iii) The institutions shall collect the Annual Tuition fee every year in advance only for that particular year either in a lumpsum or in installments, if it so opts.

- iv) The Institutions not to charge any capitation fee or any amount unauthorisedly or illegally under any other head or guise (e.g., donation etc.), either directly or indirectly, other than the fee fixed by the Committee, as collection of any such unauthorized amounts would amount to charging of Capitation Fee, and that the surplus (profit) that is generated from the collection of the Fee must be for the benefit of the Institution, and can not be diverted for other purposes or for personal gain.
- v) The Institutions are informed that fixation of the Fee Structure by the Committee will not by itself enable or permit the managements to run the relevant courses in their institutions, if they are otherwise not duly recognized and permitted by the Government or AICTE / FCI / Concerned University at any relevant time.
- vi) The above Tuition Fee is fixed for the academic year 2011-12 subject to a provision for neutralization of inflationary impact to the required extent at the beginning of the academic year 2012-13.
