The Principals of the affiliated colleges are requested to take note of the following.

As per reference first cited the private unaided MBA and MCA colleges are permitted to collect the following fees from the students admitted during 2017-18 academic year.

- (i) Rs.500/- has to be paid (as onetime payment) per student during the year of admission towards Recognition fee to JNTUH. This fee is onetime fee
- (ii) Rs 1500/- per annum per student has to be paid during the course towards Common Services Fee for the services rendered by the University to the colleges, for all years of course of study including first year.
- (iii) The Principals of the affiliated colleges are also requested to get the lists of admitted students verified by the Admission Section of JNTUH for the Academic Year 2017-18 and submit the same to the clearance section, Examination Branch JNTUH.

In view of the above, the colleges are required to remit an amount of Rs. 2000/- (Rs 500 towards Recognition fee + Rs 1500/- towards Common services rendered by the University) per candidate admitted at the time of entry. The requisite fee is to be paid in the form of a D.D. drawn on any Nationalized Bank in favour of "The Registrar, JNTUH", payable at Hyderabad.

Clearance of admission of the candidates is subject to the payment as per the details given above. As per item No. (ii) mentioned above Rs 1500/- per annum per candidate admitted shall be remitted to the University by the College during the remaining years of Course.

You are requested to produce the following certificate / records for issue of clearance for the candidates admitted at your institution in MBA / MCA during the academic year 2017-18.

- 1. Two sets of photocopies of the following documents should be submitted at JNTUH, exam branch (Original to be shown as proof).
  - (i) AICTE approval for the academic year 2017-18.
  - (ii) JNTUH affiliation for the academic year 2017-18.
  - (iii) List of candidates admitted under Minority Quota (if applicable) approved by the Convener ICET-2017 and secretary TSCHE.
  - (iv) List of candidates admitted through spot admissions and approved by TSCHE.
  - (v) List of candidates admitted in to management quota and approved by TSCHE.

You are requested to enter legibly the Roll No. Cum Hall Ticket Number (10digits) allotted as per the JNT University Hyderabad guidelines against each candidate on these two sets of Photocopies. It is also requested that each page of these two sets of photocopies of the approved lists should be signed by the Principal and Secretary of the Management duly affixing their seals.
